

Call for Museum of Contemporary Art Curator

Fondazione Antonio Morra Greco (hereinafter “The Foundation”) is looking for a the following position: Curator for its Contemporary Art projects and exhibitions.

Deadline for application is **February 20 2022, at 12 CET**.

1. Fondazione Antonio Morra Greco per l’Arte Contemporanea is a non for profit institution working in the field of contemporary Art. Further information about its history, activities and collection is available at the following link: <http://www.fondazionemorragreco.com/history/>
2. The Foundation is now looking for a candidate to be enrolled as Curator for its projects and exhibitions.
3. Successful candidate will be offered a professional contract till December 2022. The final date of the contract is subject to extension based on the needs of the Foundation and/or the projects assigned to the Curator. Average compensation for the job is fixed in € 35,000 on yearly basis. Slight differences in salary can be considered based on the effective experience of the successful candidate.
4. The activities to carry out are: Recording and cataloguing artefacts, artwork, documents and other pieces that will be displayed in the museum; Planning the installation and presentation of collections and exhibitions in the museum; Researching artists and new form of art to be displayed in the Museum; Administrative duties such as negotiating loan items, planning exhibition budgets and writing bids; Preparing written information about catalogues that will be made available to the public on the museum’s website or in other locations; Supporting the organisation of the visits related to the collections displayed; hiring and/or training museum staff and volunteers that work directly with the museum curator; supporting educational activities related to the collections displayed.
5. The above mentioned activities are based in Naples, at the main Museum of the Foundation, located in Largo proprio di Avellino, city centre. Based on the advancement of the projects and exhibitions, travels abroad can be requested.
6. The successful candidate has:
 - a) -A demonstrated history in curating and/or cultural management;
 - b) -Knowledge of the contemporary arts and culture scene
 - c) -Ability to contact artists, prepare and manage the exhibition
 - d) -Proven record in project administration and reporting
 - e) -Demonstrated commitment to equal opportunities and diversity
 - f) -Degree in the arts or humanities, along with proven research in the field of art/cultural theory and/or critique
 - g) -Minimum five years of professional experience as a curator and/or researcher in institutional jobs, as well as proven success in the implementation of outstanding international projects
 - h) -Proven track record of developing new work with artists and creative practitioners, including promoting new works or approaches to production
 - i) -Knowledge and comprehensive understanding of digital technological developments
 - j) -Excellent presentation and communication skills
 - k) -Languages: excellent knowledge of English. Knowledge of Italian is highly recommended. In any case, willingness to learn the language not known is mandatory.
